The meeting was called to order at 6:00 pm by Mayor Johnsen. The Clerk led the Pledge of Allegiance to the flag.

The minutes of the Regular meeting held on October 06, 2014 were read and approved upon motion from Trustee Henry and seconded by Trustee Buttaccio. The September Treasurer's report was presented and approved by motion by Trustee Henry, seconded by Trustee Buttaccio, unanimously carried subject to audit. A motion was made by Trustee Buttaccio, seconded by Trustee Henry to transfer \$6,000.00 from Contingency A1990.4 to Parks Contractual A7110.4 to cover expenses through May 31, 2015. Bills were authorized for payment on Abstract #6 of Audited Vouchers, General Fund totaling \$18,774.95; Water Fund totaling \$2,575.29 ; Sewer Fund totaling \$49,725.47; CDBG totaling \$0.00 and TEP totaling \$0.00; Trust & Agency Fund \$11,401.81.

**Inez Nicholson Veto Day  
November 18, 2014

**Whereas:** Inez was born to Llewellyn and Juanita Nicholson at F.F. Thompson Hospital on Main Street, Canandaigua NY, on the 18<sup>th</sup> day of November, in the year 1914; and

**Whereas:** Miss Inez Nicholson had a sister Helen and two brothers, George and Herbert; and

**Whereas:** Miss Nicholson graduated from Manchester High School, North Main Street in 1934; and

**Whereas:** Miss Inez Nicholson married Mr. Joseph Veto at St. Dominic Catholic Parsonage on July 5, 1943; and

**Whereas:** Mr. Veto served in the U.S. Army during World War II, Mrs. Veto then went to work at the Seneca Ordnance Depot in Romulus, NY (later renamed the Seneca Army Depot), stating it was the hardest job she ever had; and

**Whereas:** After the war, Mr. & Mrs. Veto moved to State Street upon the death of Mr. Veto’s father; and

**Whereas:** through the years Mrs. Veto also worked for Senator Henry Griffith, General Dynamics, Xerox and Kodak with a starting wage of \$6.00 a week; and

**Whereas:** After Mr. Veto passed away in 1977, Inez met her good friend Evelyn Collett and spent many years traveling seeing numerous states, the “star trip” being Hawaii; and

**Whereas:** In closing, Mrs. Veto expressed “I have the best neighbors in town”.
