 Please note that, by law, the Village is not responsible for replacing broken or damaged mailboxes. Unfortunately, broken mailboxes do happen. It is usually the weight of ice and snow that breaks them.

There have been more reports of dog owners not cleaning up after their pets. Not only is this a violation of village code subject to fines, it is discourteous to your neighbors. Code 27.3 states *It is unlawful for any owner of or any person harboring any dog in the Village of Manchester to permit or allow such dog to commit a nuisance upon the premises of a person.* Thank you to those that do pick up after your dog, and for those that don't, **PICK UP AFTER YOUR DOG(S)!! Fines can be up to \$250 per occurrence.**
