# VILLAGE OF MANCHESTER MINUTES OF THE REGULAR VILLAGE BOARD MEETING HELD AT 8 CLIFTON STREET, MANCHESTER NY ON FEBRUARY 7, 2022

The Clerk led the Pledge of Allegiance to the flag.

Mayor Buttaccio called the regular meeting to order at 6:00 pm.

The minutes of the Regular meeting held on January 3, 2022 were read. A motion was made by Trustee Henry, seconded by Trustee Fine, to approve the January minutes, unanimously carried.

The December Treasurer's report was presented at this time. Trustee Henry motioned to transfer \$5,000. From A1990.04 Contingency to Street Maintenance Contractual A.5110.04 to cover expenses through 5/31/2022. Seconded by Trustee Fine and carried. All Funds remain healthy except the water fund. Bills were authorized for payment on Abstract #9 of Audited Vouchers, General Fund totaling \$67,274.52; Water Fund totaling \$3,464.30; Sewer Fund totaling \$0.00; CDBG totaling \$0.00 and TEP totaling \$0.00; Trust & Agency Fund \$13,158.61.

### Reported – SANDBLASTING COMPLAINT ON SMITH TERRACE

Ms. Katherine Lancy and Mrs. Shirley Perryman addressed the Board about their concern that the Sandblasting business next to them is (alledgedly) emitting hazardous dust. They brought a napkin that they wiped down their deck and it showed a black substance. They have a video showing it coming out of the building. They said it is over everything around them and comes from the business next door. The Mayor stated he asked Code Enforcement about the situation and a letter was received from Steve DeHond.

Mr. DeHond stated that during his conversation with the property owner, Mr. Deys informed him that the DEC has inspected his property twice and have found no violations. Mr. Deys also said that he is moving to a new location within the next few months. Mr. DeHond said that if in a few months the sandblasting is still going on they will inspect the property to see if they need to return to the Planning Board with another site plan review.

Mayor Buttaccio advised that Ms. Lancy and Mrs. Perryman take that substance, have it tested and have it identified through a lab. Then present it to the Department of Environmental Conservation (DEC). Ms. Lancy said she did contact the DEC. The mayor said to get a copy of that report to show their findings.

The clerk and Ms. Lancy exchanged emails. She will send the video to the clerk. The Board will review further.

## Approved - <u>BUILDING DEPARTMENT REPORT - 2021</u>

Code Enforcement Officer Steven DeHond submitted his 2021 Building Department Report for the Village of Manchester. He also submitted a breakdown of each permit issued and the number of fire inspections completed for the year. 74 permits issued with a construction cost total of \$1,735,968.00 and Permit fees collected totaled \$2,729.00. ### Approved - RESOLUTION CALLING VILLAGE GENERAL ELECTION - RESOLUTION NO. 2-2022

# Approved -MUTUAL AID AGREEMENT WITH ONTARIO COUNTY - RESOLUTION NO. 3-2022

A RESOLUTION AUTHORIZING MUTUAL AID AGREEMENT FOR

SHARING OF HIGHWAY EQUIPMENT AND LABOR SERVICES.

**WHEREAS**, Highway and Public Works Departments throughout Ontario County and surrounding areas have a long history of cost effective and efficient sharing of labor, materials and equipment to aid each other in the completion of both routine and emergency maintenance activities; and

WHEREAS, the previous agreement is slated to expire; and

**WHEREAS**, it is in the best interest of all area municipalities to enter into a formal agreement as required by the Highway Law to continue this cooperation without financial or liability risk; and

**WHEREAS**, the Ontario County Public Works Committee has developed an agreement which meets the Highway Law and protects the interests of all; now therefore, be it

**RESOLVED**, that this agreement shall be extended to February 16, 2027, with the option to extend another five year term; and further

**RESOLVED**, that the Mayor will sign the agreement to be returned to Ontario County Public Works.

A RESOLUTION AUTHORIZATION TO ACCEPT THE NYS EMPIRE STATE DEVELOPMENT INCENTIVE PROPOSAL TO PREPARE THE MANCHESTER YARD MASTER SITE PLAN REDEVELOPMENT STRATEGY – PHASE III WITH AN EMPIRE STATE DEVELOPMENT STRATEGIC PLANNING AND FEASIBILITY STUDIES PROGRAM GRANT.

WHEREAS, Ontario County applied for and received a NYS Empire State Development (ESD)
Strategic Planning and Feasibility Studies Program grant; and

WHEREAS, Ontario County received a Working Capital Grant for ESD Project in the amount of \$32,500.00 to be used for preparation of the Manchester Rail Yard Master Site Redevelopment Strategy – Phase III (ESD Project #134,759; NYS Consolidate Funding Application #109952; CFDA#N/A; MUNIS# G2203; and;

**WHEREAS**, the Incentive Proposal requires a minimum of 50% cash match which will be provided for the ESD Grant as follows:

Ontario County Economic Development Corp	\$10,000.00
Finger Lakes Railway Corporation	\$ 2,500.00
Total Cash Match:	\$32,500.00
Total Project Cost:	\$65,000.00

**THEREFORE BE IT RESOLVED**, that the County Administrator is hereby authorized to execute the Incentive Proposal Agreement with NYS empire State Development, and all other documents necessary to effectuate the purposes of this resolution.

A letter was received from Ontario County Real Property reviewing NY State's State of Emergency ending on June 24, 2021 allowing the re-levy of municipal water charges. The clerk will send a copy of the notice that was sent to all water service billing offering protection against water service termination and the opportunity to enter into a deferred payment agreement (DPA) to Real Property Tax Services along with the attestation signed by Mayor Buttaccio stating *Pursuant to the expiration of the New York State of Emergency on June 24, 2021, I certify that my village has followed all of the requirements as outlined by the Department of Public Service (DPS) in order to allow Ontario County to relevy the unpaid waster charges onto the 2022-2023 Village Tax Bills.* 

# Approved - SHARED SERVICES AGREEMENT WITH ONTARIO COUNTY PUBLIC HEALTH RESOLUTION NO. 5-2022

The following resolution was offered by Trustee William Henry, who moved its adoption, seconded by Trustee Charles Fine, to wit:

RESOLUTION DATED February 07, 2022

A RESOLUTION AUTHORIZING THE APPOINTMENT OF MARY BEER, RN MPH AS LOCAL HEALTH OFFICER FOR THE VILLAGE OF MANCHESTER.

WHEREAS, In an effort to comply with the Shared Services Initiative Ontario County and the Village of Manchester has identified an opportunity to share and coordinate the services of Mary Beer, RN MPH, the Public Health Director of Ontario County, to act as the Local Health Officer for the Village of Manchester; and

WHEREAS, The Village of Manchester wishes to appoint Mary Beer, RN MPH, the Ontario County Public Health Director as the Village Local Health Officer; and

WHEREAS, The Ontario County Public Health Director, Mary Beer, RN MPH agrees to act at the Local Health Officer for the Village of Manchester, thereby eliminating the need for the Village to appoint and pay a local health officer; and

**WHEREAS,** Part BBB of Chapter 59 of the Laws of 2017 specifically authorizes cooperating municipalities to enter into shared services agreements; and

**WHEREAS,** The Parties wish to enter into a Shared Services Agreement providing for the appropriate service; now therefore, be it,

**RESOLVED,** In consideration of the preceding, and pursuant to New York Public Health Law §320, it is mutually agreed upon between Ontario County and the Village of Manchester, Mary Beer, RN MPH shall be appointed as the Local Health Officer; and be it further

**RESOLVED,** Mary Beer, RN MPH, in furtherance of this appointment, will investigate complaints of public health nuisances arising with the Village and when necessary to resolve said nuisances will present the facts and recommendations to the Village Board for their decision and enforcement action; and be it further

**RESOLVED,** the payment of any costs to abate a public health nuisance shall be a Village cost; and be it further

**RESOLVED,** the duration of appointment will begin **February 1, 2022** and will end on **December 31, 2025**.
